"**TAB**" means: Travel News Botswana (Pty) Ltd, trading as Travel Adventures Botswana

The "**Client**" means: the person named as the client in the Rental Agreement.

The "**vehicle**" means: the vehicle described on the Rental Agreement (including all tyres, tools, equipment, accessories and documents in and on the vehicle at the renting location) and includes any replacements for the vehicle which has been officially authorised by TAB.

Reference to the **Rental Agreement** shall be the Rental Agreement signed by the client at the time of vehicle collection and shall form part hereof.

The singular shall include the plural and vice versa, the masculine gender shall include the feminine and vice versa and natural persons shall include legal and juristic persons and vice versa.

The headings appear for reference only and shall not influence the proper interpretation of this agreement.

TERMS AND CONDITIONS

1. STANDARD RENTAL RATES INCLUDE

- 1.1. Unlimited kilometres upon itinerary approval
- 1.2. Standard insurance cover
- 1.3. Full gas bottles, water tank, GPS, Sat Phone & equipment as indicated
- 1.4. Travel pack with all relevant information
- 1.5. All applicable taxes
- 1.6. Introduction to the vehicle and equipment

1.7. Please note certain fees beyond our control are subject to change at any time before travel – including but not restricted to National Park fee increases, fuel price hikes which affect one-way vehicle relocation fees, and other third party/government increases.

2. MINIMUM RENTAL DURATION AND COSTS:

- 2.1. Standard Minimum rental period is **5 days in low and shoulder seasons, and 7 days in High season.**
- 2.2. The day of pick-up and drop off of vehicles are counted as full days irrespective of the time collected and returned.
- 2.3. No refunds are applicable for early returns unless arranged in advance and agreed by TAB.

3. BOOKING DEPOSITS AND PAYMENT TERMS

3.1. Once invoiced and/or a quote has been accepted in writing, the vehicle rental period is considered confirmed and may not be reduced/added to without consent from TAB. Where a reduced number of days is requested, it is at the discretion of TAB whether a refund/recalculation is possible for those days.

3.2 A 30% non-refundable deposit on the vehicle is required to confirm a rental, with 100% campsite and bookings fees also non-refundable, guides and extra services and deposit as indicated for any accommodations within 7 days. This becomes part of the rental payment, but is lost on cancellation by the



client. Provisional bookings are held for 14 days without deposit and are then released as cancelled unless an extension is given in writing by TAB.

3.3 Travel Adventures Botswana can book campsites and accommodation on behalf of the client. Full payment for campsites including campsite booking fee is due with the vehicle deposit to secure bookings. No campsites are confirmed until full payment has been received by TAB.

3.4. Balance of payment of the full price of the self-drive safari is due on the date shown on the confirmation/invoice and **no later than 62 days prior to departure. It is the client's responsibility to make payment within good time.**

3.5. Payment for any additional charges imposed by any supplementary accommodation or activity will be due as per the requirements of such establishments.

3.6. If any part of the balance of the self-drive safari remains unpaid by its due date, TAB reserves the right to treat the booking as cancelled, in which case the terms of these conditions concerning Cancellation by Client will apply. Vehicles and all campsites and accommodations will automatically be released.

The full invoice amount must be received into our account. We pay our own bank charges to receive your funds. Please check with your bank how to guarantee the full amount will be received by us. Common pitfalls leading to shortfalls are: selecting the "sha" (share) transaction option. Some banks also use an intermediary bank to process funds, which come with a charge. Any shortfalls for any reason will need to be settled by you prior to travel, as the booking will otherwise be considered unconfirmed.

3.7. Any payment made by visa or master card will incur a 4% admin fee. Any payments to non-Botswana properties attracts an admin fee to cover bank charges.

3.8. All credit card transactions are conducted in BWP. Due to exchange fluctuations, any amounts which may be refunded on return of the vehicle may vary from that initially debited against the credit card if not in Botswana Pula. We accept no liability for these variances and accept no claims for payment for the variances.

3.9. The client acknowledges and grants permission to TAB to charge the credit or debit card nominated at the Start of the Rental, as agreed in the Rental Agreement to which these terms and conditions apply, with any charges due to the client under the Rental Agreement, at any time during and after the rental period.

3.10. Please use your invoice number/name as a reference when making payments and **email through the proof of payment.** We cannot be held responsible for unidentified payments and hence not making timely payments to third party suppliers to secure bookings.

4. CANCELLATION BY CLIENT:

4.1. Notice of cancellation by client must be made in all cases in writing, by the person whose name is used as "Client" on the Booking Confirmation form.

4.2. Cancellation is effective from the date of receipt by TAB of such written notification.

4.3. In the event of a rental having to be cancelled, the following cancellation charges are applicable.

i. notice received 61 days or more before the departure date: only the deposit is forfeited;

ii. notice received from 60 days of the departure date the following percentage of the **total self-drive safari cost** will be payable as a cancellation charge: 61 or less day = 100%;

iii. Even if the client's insurance policy may cover cancellation it is for the client to claim any insurance money due from their insurers directly.

4.4. This cancellation applies only to TAB vehicle rental and does not apply to third party bookings. Each individual third party's cancellation fee will apply.

4.5. Without derogating from any other term contained herein, TAB shall be entitled at the expiry and/or termination of this agreement, for whatever reason, to retake possession of the vehicle wherever it may be located and from whomever is in possession thereof.



Summary of Booking Process & Deposit/Cancellation Policy:

- On enquiry, vehicle held as available for 14 days whilst campsites/other accommodations etc are booked
- **30% non-refundable deposit to be paid at 14 days for the following:**
 - The vehicle rental
 - The guide, if booked (whether specialist or standard)
 - Accommodation as per their T&C, which is usually 30% non-refundable deposit
- **100% non-refundable payment of any campsites at 14 days, and 100% TAB campsite booking fees**
- Balance payment due no later than 60 days before safari start date for remainder of invoice
- 60 days to start date of safari or for no shows – total safari cost is forfeited.

5. OFFICE HOURS:

Reservations Office Hours are:

Jan-Apr: Monday to Friday 08h00 – 17h00

May-Dec: Monday to Thursday 09h00-17h00 and Fridays: 09h00-13h00

Operations Office Hours are: Mon-Fri 08h00-17h00 year round

6. VEHICLE DELIVERY AND COLLECTION:

6.1. Deliveries and collections of vehicles from 8 am to 4 pm are included in the rental cost 5 days per week. Collections and deliveries of vehicles or airport collections and drop offs outside of this time will attract a fee as per our standard rate sheet.

6.2. Botswana: vehicles can be delivered and /or collected in all major centres – Kasane, Victoria Falls, Livingstone & Windhoek. Harare and Bulawayo and other locations on request. (Relocation fees will apply and fuel surcharges are dependent on Botswana fuel prices and fluctuations)

6.3. Transfers between Livingstone/Victoria Falls and Kasane can be arranged at extra cost.

6.4. Vehicles are available in Botswana, Namibia, Zimbabwe and Zambia (rates as per our standard rate sheet)

6.5. Delivery or collections must be arranged and confirmed prior to rental. Handover times for fully equipped vehicles take approx. 2 hours, for standard vehicles approx. 1 hour. Returns take around 30 mins.

6.6. Vehicles must be returned in the same condition as received, except cleaning. Vehicles will be professionally cleaned by TAB and charged at the rate indicated on the rate sheet.

6.7. Vehicles are supplied with a full fuel tank and customers are expected to return the vehicle with a full tank, failing which the client will be charged for the additional fuel. Jerry cans are supplied EMPTY and are to be returned empty.

6.8. Rental beyond the stipulated termination date must be authorized by TAB.

6.9. Rentals terminated earlier than the stipulated termination date are **not refundable**

6.10. Should the client request that all equipment be checked at the time of return, it is the client's responsibility to ensure the vehicle is returned with sufficient time to conduct this service. After hour fees apply.

6.11. The obligations of the client and the rights of TAB under this agreement shall continue in effect for an unspecified period of time until any claims by TAB have been settled to the satisfaction of TAB.



7. CONDITIONS OF VEHICLE HIRE

7.1 A valid **credit** card is required for the bond / excess authorization we do not accept cash or cheques. We only accept Visa and or MasterCard. Debit cards cannot be used.

7.2. Drivers must be 21 years or older, have at least 2 years' driving experience and produce a valid licence free from serious endorsements. Non-English language national driving licences must be presented in conjunction with an official translation or valid international driver's licence.

7.3. Please be aware: co-drivers not nominated by the client in the rental agreement are not insured. If the vehicle is driven by anyone other than the client, the client shall remain liable for all his/her obligations in terms hereof, and in addition, the client shall be liable to TAB as if the client had been the driver.

7.4. The client warrants that in any event the vehicle will not be driven by any person whose blood alcohol concentration exceeds the limit permitted by any applicable law or regulation or whilst under the influence of intoxicating liquor or of a narcotic drug and that every driver of the vehicle during the rental period will have a valid licence to drive the vehicle, will comply with all applicable laws and will comply in all respects with the provisions of this agreement.

7.5. No smoking in the vehicles we charge a cleaning fee of US\$250 for smoking in a vehicle.

7.6 It is compulsory for all clients to take out medevac insurance cover with OAR. See Point 12.

8. USAGE:

8.1. The Client acknowledges that he is aware of the purpose for which the vehicle was designed, as well as all safety and maintenance procedures. The Client is responsible for looking after and maintaining the vehicle during use and for returning the vehicle in good order, fair wear and tear accepted.

8.2. The vehicle may not be used for the conveyance whether of passengers or goods for reward, to propel or tow any other vehicle including any caravan or trailer, to transport goods in violation of the customs laws or in any other illegal manner

8.3. The client shall make adequate provision for the safety of the vehicle in particular he shall keep the vehicle properly locked and secured and immobilised when the vehicle is not in use.

8.4. In the event of the vehicle or any of its belongings being lost or damaged during the rental period, the Client shall be liable to cover the cost of replacement or repair and to make good on any shortages or damages to the vehicle. Note: negligent loss or damage is not covered by insurance. Insurance cover is included in the Rental Agreement, as per clauses 11 and 12 below, and will cover loss or damage due to theft of the vehicle and certain reported collision damages **only**, but **not** lost or stolen equipment, including satellite phones, or damages due to carelessness. Dents and scratches to the TA vehicle will be deemed negligent damage and the client will be liable for their repair.

9. ROAD RESTRICTIONS:

9.1. The TAB 4WD vehicles are allowed on all bitumen/tar and gravel roads as well as all recognized public 4x4 tracks in Botswana, Namibia, Zambia and Zimbabwe.

9.2. Due to seasonal changes, road restrictions may be implemented at certain times of the year and it is the responsibility of the client to abide by the changes. Current Road restrictions will be noted on the Rental Agreement.

9.3. The vehicles may not be driven off-road.



10. WILD ANIMALS:

10.1. Please be aware that your self-drive safari may take you into close contact with wild animals. TAB cannot be held responsible in the event that an attack takes place. It is the responsibility of the client to ensure their own safety. Neither TAB, nor their employees can be held responsible for any attack, injury or accident that may occur.

Please note that Botswana offers one of the last genuine wild and authentic safari experiences: campsites aren't fenced for the most part and animals wander freely, especially in Parks and Reserves. Pre-booked stays at lodges enroute can be made for those looking for a softer adventure or a break in camping! (Lodge bookings are, unfortunately, not possible once the safari has started).

11. FACILITIES:

11.1. The facilities, local prices and amenities shown in pictures or mentioned in writing are shown in good faith as generally being available. Should prices vary, or facilities not be available, TAB cannot be held responsible.

11.2. Any dispute regarding facilities must be settled with the company concerned. TAB in no way guarantees the standard of any facility (lodge/campsite/hotel) that is booked on your behalf by us and any claim must be made directly to the facility in question.

12. EMERGENCY MEDEVAC INSURANCE WITH OKAVANGO AIR RESCUE ("OAR") & PERSONAL MEDICAL/TRAVEL INSURANCE

12.1 It is a condition on booking a vehicle with TAB, that all clients be covered by OAR, **in addition to their own medical travel insurance**. OAR cover is unique in that it will move a patient from the accident scene to the most appropriate medical centre in Botswana for assessment by on the ground medics - without requiring authorization from overseas medics/insurers. Depending on the location of the accident, medevac could be by helicopter, light aircraft or road ambulance. From that point on the patient's own insurance will apply with local medics liaising with patient's international insurers.

12.2 It is a condition for all travellers to be covered by a bona fide medical insurance policy, details of which should be supplied prior to travel including policy name, number, emergency contact telephone (next of kin contacts also to be provided).

12.3 Travel insurance to cover loss/theft/delay/unexpected cancellation due to Force Majeur etc is **ESSENTIAL** and should be bought upon confirmation of your booking. TAB cannot be held responsible for such liabilities, whatever the cause.

13. VEHICLE INSURANCE:

13.1. The client (client) must insure against cancellations and for medical and personal injuries and all other usual travel risks and details must be given at the time the booking form is completed. Such a policy shall be independent of the conditions of this Rental Agreement and shall be governed by the conditions therein.

13.2. From 2021, mandatory cover with Okavango Air Rescue shall be taken out for all clients and charged to the clients accordingly. Clients must still take out their own medical and emergency insurance and provide details in advance to TAB.

13.3. Standard Insurance cover, is included for all vehicles and in all rates quoted. This is not full cover and an excess is applicable, the monetary value of which depends on the vehicle category.

13.4. No matter the reason or circumstance, the client will be liable for any damage or destruction including tyres, windscreens, windows, light damage, dents or scratches and equipment. The monetary value of any damage will be determined by a quotation from a reputable company. **A US\$50 service fee will also be charged.**



13.5. Personal property is not covered.

13.6. The client still has to pay the excess as recorded on the Rental Agreement when any claim arises.

13.7. The Standard Insurance cover is non-refundable

13.8. Insurance cover is valid in the following countries: Botswana, Namibia, Zambia and Zimbabwe.

13.9. Third party cover: the standard insurance cover includes Third party cover for Botswana, Namibia, and Zimbabwe.

13.10. Third Party cover for **Zambia** needs to be purchased at the border entry point – cost is approx.

USD200 per vehicle. If the vehicle is being delivered to you in Zambia these fees are covered and included in the vehicle relocation fee charged.

13.11. An excess applies to each vehicle depending on the category.

13.12. Additional optional Collision Damage Waiver is available and may reduce the respective excess to the amount stipulated on the rate sheet and recorded on the Rental Agreement.

14. INSURANCE OPTIONS

14.1. All vehicles come with the **Standard Excess Insurance**. There is an option to pay for additional **CDW Super Excess Insurance**.

14.2 Insurance cover (Standard/Super) is applicable only in the event of accidents including one or multiple vehicles or theft or fire. Insurance cover is applicable on presentation of a police report and the incident reported to TAB within 24 hours. An excess will apply depending on the insurance option paid for. TAB makes no undertaking to make any payment or admit liability until TAB has investigated the accident to their satisfaction.

14.3. Any equipment damaged or lost must be paid for at the replacement value before the clients' departure, no matter the reason or circumstances. Equipment must be returned to TAB in the condition and entirety as per the signed inventory on collection.

14.4. Credit card transactions are processed by the clients' bank and is ultimately responsible for the release of funds should it not be utilised by TAB.

14.5. Fully Equipped Vehicle AND Standard Vehicle insurance are both charged per calendar day.

Standard Excess Insurance (rates as per standard rate sheet)

- The standard excess applies in the event of any damage to either our vehicle or third party property pending the circumstances.
- The client will also be fully liable for replacing or repairing damaged windscreens and tyres.
- The standard excess will be taken on vehicle collection. Currently **USD4000 for 2026**.
- The standard excess can be paid by credit card only.
- The "bond" amount will be authorized with the bank, and will not be available until the return of the vehicle to the agreed location, on the agreed date, with no damage incurred to the TAB vehicle or third party property and no items or equipment are lost or damaged.
- In the event of a single vehicle accident a double standard excess, Currently **USD 7630**, is payable by the client.
- The double standard excess is also the maximum amount that the client will be liable for EXCEPT when negligence is involved.
- In the event that TAB has to claim from its insurers for major damages or replacement and as per points 13.4 / 13.11 above, the clients will be liable for the insurance excess regardless of circumstance - 15% of claim - Minimum Currently USD 1650.00.



CDW Super Excess Insurance (rates as per our standard sheet)

- CDW Super will cancel the excess for any vehicle and third party property damage and the cost of **replacing** 1x tyre OR the **replacement** of 1 windscreen, radio theft and recovery costs (within Botswana).
- Currently, a security deposit of **USD380** is payable at the time of pickup to ensure that the vehicle is returned to the agreed location, on the agreed date and no items are lost or damaged.
- In the event of a single vehicle accident a single standard excess, Currently **USD 3600**, is payable by the client.
- The single standard excess is also the maximum amount that the client will be liable for except when negligence is involved.
- In case of any damage to the TAB vehicle or third party property, a second insurance cover payment will be collected to cover the excess for any subsequent damage when negligence is involved.

None of the above insurance options cover negligent damage to vehicles and/or equipment. Dents and scratches caused by the client's negligence will, therefore, be for their own account. TAB is hereby authorised to deduct such amounts from the client's credit card, to cover any expenses incurred through the client's negligent damage to any TAB vehicle as outlined below.

IMPORTANT: Client liability

The client is fully liable for any damage to the TAB vehicle or third party property if:

- the terms of the rental contract are breached
- the damages are sustained whilst the client/driver is in breach of any traffic laws or ordinances
- damage to the vehicle is caused by careless, wilful or reckless driving
- damages are sustained whilst the client/driver is driving under the influence of alcohol or drugs
- damages are sustained whilst the client/driver is driving on restricted roads or off road
- any damage is caused by driving through water or salt water damage this includes getting stuck in the salt pans
- the vehicle was driven in a country in which written approval was not obtained from TAB
- the clutch sustained damage / abuse
- driving between sunset and sunrise
- damage is sustained to the undercarriage
- the gearbox is damaged due to incorrect use of the clutch/handbrake
- the client fails to stop driving when a dashboard warning light indicates a problem
- the client/driver incorrectly use the diff locks and/or transfer cases, i.e. driving on tar roads with electronic diffs engaged or with 4x4 mode engaged

TAB is under no obligation to provide a replacement vehicle nor will any refund be made if damages are sustained for any one of the above reasons.

Please Note: A replacement vehicle will only be dispatched once payment of all damages / recovery costs to the first vehicle is made on an as available basis. TAB reserves the right to withhold a replacement vehicle; this does not entitle the client to any claims against TAB.

The client shall also be liable for all fines, penalties and the like (including all legal costs incurred by TAB for its attorneys in accordance with their usual charges at the time) for parking, traffic and other criminal offences arising out of or concerning the use of the vehicle during the rental period and the client accordingly indemnifies TAB against all such liability.



- Any claims will be finalised within 21 days of the vehicle's return, if this is not possible for whatever reason TAB will advise the client accordingly.
- TAB will charge an administration fee of US\$50 in addition to the damage costs of replacement or repair.

PROVISIONS

All provisions **MUST** be taken on safari from departure location including enough fuel, drinking water, wood and food. There are very few options to purchase anything through the wildlife/wilderness Parks and Game Reserves. Our pre-departure check list will assist here, but please note this serves as a guideline only. Please discuss your fuel needs with Reservations on enquiry when planning your route.

15. ACCIDENTS

15.1. By law all accidents must be reported to TAB and the Local Police within 24hrs. Failing to report accidents voids all insurance cover and the client becomes fully liable for all costs. In remote areas use the satellite phone to report to TAB.

15.2. If, during the rental period, the vehicle is involved in any accident or collision or is lost or the vehicle or any part of it is stolen, the client shall take every reasonable precaution to safeguard the interests of TAB, including where appropriate, but not limited to, obtaining the name and address of everyone involved and of possible witnesses: co-operating with TAB in the investigation, the making and/or defence of any claim action relating to the incident (including the making of an affidavit if the client is requested to do so).

15.3. The client accepts that the TAB vehicle is used at their own risk.

15.4. If the rental vehicle is involved in an accident or is not drivable due to mechanical breakdown a replacement vehicle may be collected from the Maun Branch if available:

- If the client requires a replacement vehicle to be delivered, then these charges will be for the client's account.
- The client is responsible for the recovery of the damaged vehicle to the Maun branch.
- If the client is unable to take a replacement vehicle, no refunds for early termination of the contract will be considered.
- No refund of rental days lost will be considered during the period in which a replacement vehicle is being replaced.
- Should the client continue with a replacement vehicle then a new rental contract and insurance conditions will apply.
- Should a replacement be needed due to a fault of TAB, as determined by TAB, we will replace the vehicle within 24hrs if available, alternatively the client will be refunded for the balance of the days remaining.

16. REPAIRS AND MECHANICAL FAILURES OF VEHICLES & EQUIPMENT

16.1. Repairs of up to US\$200 can be effected without prior authorization. On higher amounts prior authorization is required from TAB.

16.2. Where serious mechanical failure occurs due to standard wear and tear and which cannot be repaired timeously, a replacement vehicle will be delivered in Botswana, if available



16.3. Should a replacement vehicle not be available, the client will be refunded for the days in which the vehicle is not in use.

16.4. In most cases vehicles are still covered under the new vehicle manufacturer's warranty and their warranty conditions will apply where mechanical failures occur. It is important to remember that TAB is not the manufacturer of the vehicle or equipment but will do its utmost to select and offer the best and most recommended vehicles and equipment.

16.5 This applies to satellite phones and satellite navigation systems.

17. EMERGENCIES:

17.1. TAB is on call 24 hours per day for medical emergencies (to liaise with OAR) and serious mechanical failure. However, due to Botswana conditions, recovery may only be in daylight hours. In this regard satellite phone calls to TAB or its agents are free of charge. In the event that a client requests assistance which is not an emergency, a callout fee will be charged. The fee will be dependent on distance from Maun and only valid within Northern & Central Botswana. Outside of Botswana separate charges will apply. TAB reserves the right to apply the applicable charge. The charge is per our standard rate sheet as in charged at a per km rate. (Should you call for assistance and the relief vehicle and crew leave Maun to assist you will be charged the callout fee)

18. CROSS BORDER SURCHARGES:

18.1. TAB supplies the vehicle papers and a letter of authorization to drive our vehicle; clients are responsible for their own cross border formalities.

19. LIABILITY OF TRAVEL ADVENTURES BOTSWANA:

19.1. TAB will not accept responsibility over things, persons, or matter over which it has no direct control, including the quality of third party establishments, nor will it be held liable for the death, injury or illness of any clients or persons accompanying them.

19.2. TAB shall not be liable for any damage to, or any damage arising out of any defect in, or mechanical failure of the vehicle, nor for any loss, or damage to, any property transported or left in the vehicle, nor for any indirect damages, consequential loss of profits or special damages of any kind for any breach of this agreement, or arising out of any cause whatsoever, irrespective whether or not the loss resulted from the negligence of TAB, its agents or employees. TAB accepts no responsibility and shall not be liable for delays occasioned by a breakdown or any other circumstance.

19.3 TAB will not be held liable for the failure of a satellite phone or GPS.

19.4 TAB will not be held liable for cancellation due to Force Majeure/unexpected circumstances.

19.5 Credits will not be possible. Adequate insurance must cover all eventualities.

20. CANCELLATIONS/ITINERARY AMENDMENTS BY TRAVEL ADVENTURES BOTSWANA:

20.1. TAB reserves the right to cancel a booking without compensation due to Force Majeure, or circumstances beyond TAB's control. However, TAB will endeavour to first offer a suitable alternative (such as alternative dates, re-routing as available/appropriate) of a similar standard or cost. Additional costs will be borne by the client.

20.2. More than 2 nights changed from the original itinerary incurs \$100 amendment fee per vehicle or \$10 ppn, whichever is the greater.

20.3. Provided TAB has used its best endeavours to comply with the above clause, it will not be liable for any breach of contract or claim that may arise as a result of any inconvenience or loss suffered by the client.

20.4. In the event a third party and/or TAB must offer a refund due to unused vehicle/service/s, refunds will be sent with all bank charges borne by the client and not TAB.



21. GENERAL:

21.1. It is hereby agreed that this agreement is governed by the law of Botswana.

21.2. The client agrees that TAB is entitled, but not obliged, in its discretion, to institute any action or proceedings for enforcing any of its right under this agreement in the Magistrate's Court, notwithstanding the amount in dispute, and the client consents to the jurisdiction of the Magistrates Court.

21.3. If TAB institutes any legal proceedings against the client to enforce any of its rights under this agreement TAB shall be entitled to recover from the client all the legal costs it incurs to its own attorneys in accordance with their usual charges and assessed as between attorney and own client.

21.4. If the client enters into this agreement on behalf of any principal, including any undisclosed principal, the client shall be personally liable jointly and severally with his/her principal.

21.5. The client chooses the address specified in the Rental Agreement as his/her *domicilium citandi et executandi* and any notice posted to the client to this address shall be deemed to be received seven days after the date on which it is posted unless the client proves the contrary.

22. TRAFFIC OFFENCES

22.1. The hirer is advised that TAB will debit the hirer's credit card for any infringement fee for an offence where the offence was committed during the period of hire and was a speeding offence, a toll offence or an offence in respect of failure to comply with the directions given by a traffic signal where that offence was detected by approved vehicle surveillance equipment or an offence for parking in any portion of a road in breach of any bylaw or a road controlling authority.

22.2. TAB will charge an administration fee of US\$200 in addition to the infringement fee should the offense not be reported to TAB at the end of the rental.

23. PLEASE NOTE:

23.1. Rates and conditions may be subject to change without notice. All information may be subject to change and all measurements and volumes shown are approximate.

Appendix 1

24. ADDENDUM: WATER DAMAGE (to be signed by hirer on arrival)

24.1. All clients renting vehicles from TAB will be required to sign the water damage addendum and/or super insurance addendum.

24.2. Please note that driving through water with a Travel Adventures Vehicle can lead to damages which are not covered by any insurance cover and will not classified as wear and tear.

24.3. Any damages to a vehicle as a result of driving through water will be a direct cost to the hirer of the vehicle.

24.4. Damage can be and is not limited to the contamination and or replacement of oils and grease i.e. wheel bearings, gearbox and transfer case. This includes but is not limited to damages to the vehicle's starter and/or alternator and brakes.

WATER DAMAGE is specifically excluded from the insurance and is not covered by the regular servicing of the vehicle.

- Please note that any damages or costs associated with driving through water will be for the expense of the hirer.
- All Travel Adventures vehicles are fitted with water indicator sensors which are checked before and after each rental.



- The Toyota specification is wheel height for wading through water but please be informed that this is done **entirely at the risk of the client / renter** of the vehicle Any costs relating to the vehicle being driven in water will be for the account of the client.
